Subject: Transaction charges for usage of eNWR

In supersession to Repository circular Ref no. NERL/BUSINESS- 001/2019/009 dated April 16, 2019. Repository Participants – Account Maintenance and their clients are hereby informed that in terms of the guidelines on eNWR charges levied to client/depositors by RPs and Repositories issued by the Authority on July 31, 2019, the eNWR (electronic Negotiable Warehouse Receipts) charges to be levied to the Non-Exchange depositors/clients are given below:

i.	Account Opening Charges	Nil	Nil
ii.	Deposit and Withdrawal	15/MT	20/MT

iv.	Extension after expiry of first eNWR validity	10/MT	10/MT
V.	Charges for new holder of eNWR- Pledge/ depledge /on-market /off- market	10/MT	10/MT

Annual Maintenance charges of Rs. 200 for Farmer/FPO/Individuals/Sole Proprietary firms and Rs. 500 for Partnership firms/ Limited companies etc. would be levied.

Charge for usage of eNNWR (electronic Non-Negotiable Warehouse Receipts)/ eWR (electronic Warehouse Receipts) for all types of depositors would be Rs. 15/MT of quantity deposited against eNNWR/eWR.

Repository Participants are not permitted to add any further charges in addition to aforementioned charges.

The transactional charges are applicable from August 01, 2019 and shall be valid till further notice. The transaction charges levied for usage of eNWR for NCDEX Market remains unchanged.
