Central S.O. 4471(E) dated December 16, 2019 under Essential Commodities Act, 1955; exempted stock of specific commodities, in which derivatives trading is permissible, from stock limit if such commodities are kept for delivery on exchange platforms in warehouses accredited by the commodities derivatives exchanges and registered with Warehousing Development and Regulatory Authority.

का.आ. 4471(अ).—केंद्रीय सरकार, आवश्यक वस्तु अधिनियम, 1955 (1955 का 10) की धारा 3 द्वारा प्रदत्त शक्तियों का प्रयोग करते हुए, विनिर्दिष्ट खाद्य पदार्थों में अनुज्ञापन संबंधी अपेक्षाएं, स्टॉक सीमा और संचलन निर्वंधन हटाना आदेश, 2016 का और संशोधन करने के लिए निम्नलिखित आदेश करती है, अर्थात्:-

1. संक्षिप्त नाम और प्रारम्भ-

(1) इस आदेश का संक्षिप्त नाम विनिर्दिष्ट खाद्य पदार्थों में अनुज्ञापन संबंधी अपेक्षाएं, स्टॉक सीमा और संचलन निर्वंधन हटाना (छटा संशोधन) आदेश, 2019 है।

(2) यह राजपत्र में इसके प्रकाशन की तारीख को प्रवृत्त होगा।

2. विनिर्दिष्ट खाद्य पदार्थों में अनुज्ञापन संबंधी अपेक्षाएं, स्टॉक सीमा और संचलन निर्वंधन हटाना आदेश, 2016 (जिसे इसके पश्चात उक्त आदेश कहा गया है) के खंड 3 के उप-खंड (3) के स्थान पर निम्नलिखित खंड रखा जाएगा, अर्थात्:

“(3) उप खंड (2) में अंतर्विष्ट कोई भी बात -

(क) राज्य के बाहर किसी स्थान पर चीनी, खाद्य तेलों और खाद्य तिलहनों के परिवहन, वितरण और बिक्री को प्रभावित नहीं करेगी;

(ख) विनिर्दिष्ट वस्तुओं (इस आदेश के प्रयोजन के लिए, केंद्रीय सरकार द्वारा विनिर्दिष्ट), जिनमें व्युत्पन्न व्यापार की अनुज्ञेय है और जिन्हें एक्सचेंज प्लेटफार्मों को सुपुर्द किए जाने के लिए डेरिवेटिव एक्सचेंजों द्वारा प्रत्यायित और

भांडागारण विकास और विनियामक प्राधिकरण के साथ रजिस्ट्रीकृत भांडागारों में रखा जाना है, पर लागू नहीं होगी और यह छूट तब तक अनुमेय होगी जब तक कि इन शर्तों को पूरा किया जाना रहेगा।"

3. उक्त आदेश में खंड 4 में, अंक, अक्षर और शब्द "17 जून, 1978" के स्थान पर अंक, अक्षर और शब्द "9 जून, 1978" रखा जाएगा।

ORDER

New Delhi, the 16th December, 2019

S.O. 4471(E).—In exercise of the powers conferred by section 3 of the Essential Commodities Act, 1955 (10 of 1955), the Central Government hereby makes the following order further to amend the Removal of Licensing Requirements, Stock Limits and Movement Restrictions on Specified Foodstuffs Order, 2016, namely:—

1. Short Title and Commencement-

- (1) This order may be called the Removal of Licensing Requirements, Stock Limits and Movement Restrictions on Specified Foodstuffs (Sixth Amendment) Order, 2019.
- (2) It shall come into force on the date of its publication in the Official Gazette.

2. In the Removal of Licensing Requirements, Stock Limits and Movement Restrictions on Specified Foodstuffs Order, 2016 (hereinafter referred to as the said order), for sub-clause (3) of clause 3, the following clause shall be substituted, namely:—

“(3) Nothing contained in sub-clause (2) shall -

- (a) affect the transport, distribution or disposal of sugar, edible oils and edible oilseeds to places outside the State;
- (b) apply to the stock of specified commodities (specified by the Central Government for the purpose of this order), in which derivatives trading is permissible and kept in warehouses accredited by a commodity derivatives exchange and registered with the Warehouses Development and Regulatory Authority for delivery on exchange platforms and this exemption shall be available as long as these conditions are fulfilled.”.

3. In the said order, in clause 4, for the figures, letters and word “17th June, 1978”, the figures, letters and word “9th June, 1978” shall be substituted.
