Subject : Introduction of NERL Warehouse Space Reservation system for NCDEX Deposits

Reference is drawn to NCDEX circular no. NCDEX/OPERATIONS-100/2015/397 dated December 30, 2015 on Automated Warehouse Space Reservation System for deposit of Commodities in NCDEX Approved warehouses. Warehousemen and clients are hereby informed that with effect from 29th November 2019, COMTRACK Warehouse Space Reservation functionality will be replaced and migrated to the new warehouse reservation system on NERL platform. Warehousemen and Clients are required to login in the new system through their existing e-Repository login credentials into NERL Warehouse Space Reservation System (URL: https://wsr.erepository.in) to perform space booking and its allied activities.

Client and warehousemen are informed to note following points on this migration

- Post effective date, for NCDEX stocks, booking is mandatory through new warehouse space reservation system prior to deposit in E-Repository.
- All the deposits in the NERL E-repository system post effective date will only happen against the valid booking numbers generated through the new warehouse space reservation system.
- All valid open bookings of COMTRACK prior to effective date will be permitted for deposit in E-Repository system till its validity.
- Existing stocks in the COMTRACK which are valid for migration from COMTRACK to E-repository system will be controlled by NERL as a onetime migration activity.
- All other parameters such as booking timings, booking limit, deposit end date etc. remains unchanged.

It is informed to the market participants that waiting list functionality in the warehouse space reservation system is currently not available.

Booking system and deposit in repository system won't be available on 27th November 2019 & 28th November 2019 for NCDEX commodities for facilitating migration from COMTRACK.
